NIGERIA LEADS THE WAY – 100 patients randomised!

Following several months of preparation, the WOMAN trial has finally commenced recruitment of patients in Nigeria. Pre-trial activities reached a peak when the trial coordinators from the London School of Hygiene & Tropical Medicine held a meeting with 25 principal investigators at the University College Hospital, Ibadan, on March 5-6, 2010. The meeting was memorable and successful as you can see from the happy faces below!



It served as a stimulus for principal investigators, as training of research teams was subsequently conducted at several sites. It was heartwarming to observe a quick pace of recruitment across different sites following the commencement of the trial. One is particularly encouraged by the reports of enthusiasm and goodwill demonstrated by members of research teams and other clinical staff at the sites. Given this wide support, we will admonish all principal investigators to establish mechanisms, which will ensure that all eligible women are recruited. We should continuously devise means to stimulate the interest of all trial team members. Remember, it is a long path to 2015! We also call on all principal investigators who are yet to commence the trial to accelerate necessary pre-trial activities in order to start recruitment.

While thanking everyone for the good work, we enjoin you all to maintain the pace of recruitment.

Our success story is the determination of the team to see this trial through. The cooperation of the consultant staff and the hospital management has contributed in no small measure to the trial. We have a team that fully understands the importance of the trial and the possible impact on the maternal health situation in the developing world. All the doctors in the departments of OBGY are identifiers of potential trial participants as soon as postpartum bleeding cases are seen. The PI or the co-investigator Dr Owodunni is informed and within a short time the participation is discussed with the client or the relative. If the eligible client or her relations give informed consent according to the protocol, then she is randomised.

Our sister hospitals in the Zamfara state are informed of the study for early referral to the centre when difficult PPH cases are seen. Our response time to emergency obstetric cases has improved tremendously in the recent past due to the increased number of resident doctors in the unit. The combination of all of the above has led us to this stage. We are poised to continue to contribute our part to improving maternal and newborn health in our communities. *Kamil Shoretire, PI, FMC Gusau*

RECRUITING THE FIRST PATIENT: TRAINING BY DOING



Recruiting our first patient for the WOMAN trial also provided an opportunity for a 'practical' session following our training presentation.

The presentation was done on the day before our first recruitment. I was on call and had just completed a Caesarean Section when I noticed activity in the other labour ward theatre. Out of curiosity I stopped over to find out what was happening. There was an 18-year old girl bleeding from cervical laceration.

I promptly brought a pack of the trial drugs and called all the residents together for a 'practical' session to what we all learned the previous day. I also learned a lot from the session. Questions were asked and we all found answers. Though not planned in this case, this kind of learning process may help in sensitising colleagues to the trial in our centers.

This was our first recruitment and also, by chance, the first randomisation for the WOMAN trial.
